With reference to email dated 28.08.2021 received from Additional Secretary, DoSE&L, MoE, GoI regarding celebration of Shikshak Parv, 2021 commencing from 5th September 2021 till 17th September, 2021 through virtual mode vide which it is informed that in recognition of valuable contribution of our teachers during the pandemic and to take the National Education Policy (NEP) 2020 a step forward, like the previous year, this year too, the Department of School Education & Literacy, Ministry of Education would be celebrating Shikshak Parv, 2021 commencing from 5th September, 2021 till 17th September, 2021 through virtual mode. The theme for this year's Shikshak Parv has been decided keeping in view the Azadi Ka Amrit Mahotsav celebrations, as 'Quality and Sustainable Schools: Learnings from the Schools in India'.

During the Shikshak Parv, it has been decided to organize a one-day Inaugural Conclave on 7th September, 2021 in which the Hon'ble Prime Minister of India has consented to grace the occasion. He will be addressing a large number of teachers, parents and students on this occasion. The conclave will be followed by webinars, discussions,

presentations etc. upto 17th September, 2021 in which the educational practitioners from various schools of the country have been invited to share their experience, learnings and the roadmap ahead.
